

# **PUNJAB, PAKISTAN**

Punjab is a geopolitical, cultural, and historical region in South Asia, specifically in the northern part of the Indian subcontinent, comprising areas of eastern Pakistan and northern India.

Punjab state has 22 districts and its population in 2020 is estimated to be 30 Million; Muslims constitute just under 2% of the total population in Punjab.

## **ANJUMAN SAMAJI BEHBOOD**

Anjuman Samaji Behbood (ASB) which means social welfare organisation was established in 1964 as a non-profit Non-Government Organization (NGO) and registered in 1975 under the Directorate of Social Welfare, government of Punjab. The charity started its activities with a profile of general welfare activities and currently is also helping communities living in low income settlements install underground piping to channel sewage to the main municipal sewage line. ASB wants to make people self-reliant instead of dependent on projects and has opened a way to build sustainable co-ordination, cohesiveness and create a sense of ownership in communities and at all levels of government.

## **THE NEED**

Inflation and prices are increasing daily in Punjab and Pakistan as a whole and this is resulting in the poor becoming poorer. Unemployment is very high and in the villages there are many young people who do not have work and are therefore unable to support their families.

## **INCOME GENERATION SCHEME**

This scheme give those who are struggling financially the seeds to earn a livelihood of their own, thereby empowering them with the tools for their own success. ASB focus on very remote and deprived areas of Pakistan where the shia population is dense; the scheme enables beneficiaries to grow and start a new life.

The scheme operates under strict terms and condition and loans are only provided to those people who are able to could follow ASB's rules and regulations.

The scheme provides loans so that beneficiaries can buy items to start small businesses such as book shops, fruit shops, tuck shops and other small shops.



## CASE ONE

The beneficiary is an elderly citizen. He goes all over Pakistan on the occasions of Majalis and other related Islamic events/gathering where he sells Islamic Books and other useful printed Islamic literature. He was hand to mouth due to high inflation. He is the sole supporter of his family. He did not have a variety of books to sell as he did not have the financial resources to buy and sell more books. He was also struggling with the cost of travel. He applied for financial assistance so that he can expand his book selling activities and on receiving funds through this scheme he has purchased books for selling. He prays for the donors and all members of WF-AID for this assistance and is contented that now he can expand his business and earn more to support his family easily.

The beneficiary is a poor syed of Wandi Syedan Wali of Kalabagh. He has 7 children. He was a Cycle Rickshaw driver, but customers now prefer auto Rickshaws and his old manual and human pulled Cycle Rikshaw became idle. He used to look for customers all day but only a few people used his service. In the evening he was coming home with only few rupees in his pocket. Then he started working as a labourer in a salt mine with a very low salary and when salt mines closed due to flooding he lost his job. He had taken a one thousand-rupee loan, but could not pay it back. He was very sad and disappointed. He applied for help through this scheme and assistance in his earning activity with which he purchased an auto Rickshaw and now he is very happy. Now he can stand in the line of Auto Rickshaws for service. His whole family is very glad, praying for those who helped them in this difficult time.

The beneficiary's father died when he was infant. He stopped his education unwillingly and became a laborer to support his widowed mother and sisters. Before receiving the support of this scheme he would purchase vegetables, put them in a big pot and go to other side of the river Indus to sell them from door to door. In the evening he would return home with whatever money he had earnt and that is how he was supporting his family. He was hard working but due to a lack of enough money, he was only making a tiny profit. Now, with the help of this scheme he is very happy, he takes a large quantity of vegetables to the other side of river. He earns from there and come back to his village. Then he sells vegetable the remaining vegetables in his village so that he gets some extra money. Now his family is very happy and prays for the donor and members of WF-AID for their help and kindness.
